Overview

Corban Rhodes is a seasoned litigator who has recovered more than a billion dollars for consumers and investors in some of the country's largest and most historic cybersecurity, data privacy and securities fraud cases. Working at the intersection of law and technology, Corban focuses on cases that involve the intentional misuse or misappropriation of consumer data and data breaches.

As co-lead plaintiffs' counsel in the *Facebook Biometric Information Privacy Litigation* matter, Corban helped secure a landmark \$650 million settlement, in one of the first cases asserting consumers' biometric privacy rights under Illinois law. He has litigated cases of negligence or malfeasance leading to data breaches, including a class action against Yahoo for one of the largest known data breaches in history that affected nearly 3 billion consumers. Continuing his groundbreaking work at this critical moment for privacy rights and the law, he currently represents consumers in pivotal web browser privacy cases, including the *Calhoun v. Google* and *Google RTB Consumer Privacy Litigation* matters.

Corban also prosecutes complex securities fraud cases on behalf of institutional investors, representing both large public pension funds and individual investors. He successfully resolved dozens of cases against some of the largest Wall Street banks in the wake of the mortgage-backed securities financial crisis. His work in securities fraud cases has held companies accountable to investors for fraud and market manipulation in the banking, pharmaceutical, and manufacturing sectors in some of the largest securities class actions of the last decade.

Corban has been recognized by *Law360* as a Rising Star and one of five attorneys on its Top Attorneys Under 40 for Consumer Protection. He was also named by *Benchmark Litigation* as a Future Star and on its New York 40 Under 40 list and by *Super Lawyers* as a New York Rising Star, and he received a Thurgood Marshall Award for his pro bono representation of a death row



inmate appealing from capital punishment. He is an active member of the Sedona Conference Working Group 11 on Data Security and Privacy Liability, and sits on the *Law360* Cybersecurity & Privacy Editorial Board. He is a regular speaker and writer on issues related to protecting the rights of the individual against corporate malfeasance.

Representative Matters

State of New Mexico, ex rel. Raúl Torres, Attorney General v. Facebook Inc., No. D-101-CV-2021-00132, Corban represents the State of New Mexico in a case alleging that Facebook deceived its users about third party access to user data in the wake of the Cambridge Analytica scandal.

Kurowski v. Rush System for Health, No. 22 Civ. 5380 (MFK), Corban represents hospital patients suing for violation of their privacy when their health data was allegedly sent to third parties for marketing purposes.

In re Facebook Biometric Information Privacy Litigation, co-lead counsel who secured a landmark \$650 million privacy settlement on behalf of consumers alleging Facebook violated the Illinois Biometric Privacy Law.

In re Google RTB Consumer Privacy Litigation, representing consumers alleging Google breaches its contractual promise not to sell users' personal information billions of times every day by rebroadcasting data during real time bidding auctions, exposing it to potential ad buyers and participants surveilling the auctions with no intent to purchase ads.



Calhoun, et al. v. Google, litigating privacy action brought by Google Chrome customers whose PII was collected while “unsynced” with any Google account in violation of contractual promises.

In re Yahoo! Inc. Customer Data Breach Security Litigation, secured a \$117.5 million settlement on behalf of approximately 194 million class members alleging multiple data breaches over five years, each of which Yahoo failed to timely disclose.
