Representative Matters

With the Federal Trade Commission:

Proposed acquisition of iRobot by Amazon. Transaction abandoned after FTC investigation.

FTC v. Penn State Hershey Medical Center (M.D. Pa.) (3d Cir.). Achieved a favorable Third Circuit ruling enjoining the proposed merger of two hospital systems in Harrisburg, Pennsylvania.

In the Matter of Becton, Dickinson, and Company / C.R. Bard. Resulted in an FTC final consent order requiring the divestiture of assets.

With the Office of the New York State Attorney General:

United States, State of New York, et al. v. AT&T, Inc. and T-Mobile (D.D.C.). Co-led the plaintiff states in a case brought by states and the federal government to enjoin the proposed acquisition of T-Mobile by AT&T, ultimately resulting the abandonment of the transaction.

State of New York v. AU Optronics Corp. (N.D. Cal.). Secured a settlement awarding damages to state purchasers in a case against major technology companies involved in an illegal conspiracy to fix the prices of LCD panels.

State of Texas, et al. v. Penguin Group (USA) Inc. (S.D.N.Y.). Achieved a favorable ruling in this e-books price-fixing case.
